2. Alias names and/or addresses populated by the address history tool will be billed at the al-a-carte rates.
3. Third party fees incurred by states for MVR reports will be passed through to End-User in addition to Global HR Research fees. States such as Pennsylvania & New Hampshire require additional charges for overnight shipping of requests and results. Such states do not accept report requests via email, phone or any other electronic method.
4. Pricing listed above are based on payments based on cash or check on a monthly or bi-monthly invoice schedule and are in accordance with the agreed upon payment terms listed in the End-User Service Agreement. Payments made by credit cards are subject to additional fees.

Additionally, Global HR Research will automatically perform confirmation record searches at court house (s) of record origin. Confirmation record searches will be billed to End-User at al-a-carte or individual search price.
